

POKÉMON TRAINER CENTRAL ACCOUNT – PARENTAL CONSENT FORM

Dear Parent or Legal Guardian:

Your child recently attempted to create a Pokémon Trainer Central (“PTC”) account with The Pokémon Company International, Inc. (“Pokémon” or “we” or “us”) via the website [Pokemon.com](http://Pokemon.com). Maintaining a PTC account is required to access certain Pokémon products and services. For example, a PTC account is required to access Pokémon Trading Card Game Live, and a PTC account may be used to participate in real-world Play! Pokémon events. Additionally, PTC account credentials may be used to authenticate identity on certain third-party–operated services such as Pokémon GO and Pokémon’s customer support portal.

Establishing a PTC account requires Pokémon to collect personal information about you and your child in accordance with our Privacy Notice, found at <https://www.pokemon.com/us/legal/privacy-notice> (“Privacy Notice”). In order for your child to establish a PTC account, we need you to create an account first and then add your child to the account. You are completing this form so that we can verify your identity and complete the account creation process.
